1. Please complete all questions on the following pages and sign all documents.
2. Make sure you check the box of the property you are putting in the application to live at. When your application comes to the top of one of the properties, your application for any other properties will be removed. The property manager will be contacting applicants once they come to the top of the list.
3. Applications may be turned in at any site listed or mailed in to 411 SE 8th Street Evansville, IN 47713. Applications are maintained by date and time of received waiting list application and bedroom size based on family size.
4. Applicants must report address, phone number and family size changes after application is turned in.

Buckner Towers – 717 Cherry Street (0-2 bedroom units) Buckner Towers is a welcoming community with plenty to offer its residents. The property is located in the booming downtown Evansville. Utilities are included.

Kennedy Towers – 315 Martin Luther King Jr Blvd (0-2 bedroom units) Kennedy Towers is a welcoming community with plenty to offer its residents. It's located in the booming downtown area of Evansville. Utilities are included.

Schnute Apartments – 1030 Franklin Street (0-2 bedroom units) Home to an engaging and friendly group of residents, with an emphasis towards a self-sustained lifestyle, including being close to shopping and other necessities. Utilities are included.
